This contract is between Bernard Laperrière and \_\_\_\_\_ (Buyer)

The terms and conditions outlined in this contract are to ensure the well-being of the dog.

**The Buyer Agrees To:**

Provide a safe and comfortable environment, provide rapid medical attention, ensure the dog stays parasite free, keep vaccinations up to date and to provide appropriate nutrition and fresh water. If the terms and conditions are not respected any and all warranties will not be honoured.

All puppies are sold and delivered with a non-reproduction contract registered with the C.K.C (Canadian Kennel Club). The aforementioned contract can be removed, at the breeder's cost, if the following conditions are proven to be met :

- Acquire, between the ages of 24 and 30 months, a result of EXCELLENT or GOOD from the Orthopedic Foundation for Animals (OFA) and;
- Acquire a FDJ (Field Dog Junior) title approved by the C.K.C.

In the case where the buyer can no longer keep the puppy, the breeder will be alerted as soon as possible and offered the first choice, either to take back or refuse the puppy without cost (the registration papers will be reclaimed with the puppy). All reimbursements will be at the discretion of the breeder upon proof of a valid claim.

The buyer must bring their puppy to a qualified veterinarian within 72 hours (following taking possession) for a physical examination. If the veterinarian finds a major injury or illness the breeder can (at his discretion) reimburse the purchase price, or exchange the puppy with a puppy from a future litter (only with a signed report from a certified and qualified veterinarian). The breeder reserves the right to have an examination done, to allow for a second opinion, from the veterinarian of his choice, at his cost.

**The Breeder Agrees To:**

Deliver a healthy puppy; vaccinated, dewormed, tattooed or microchipped, with a health booklet, registered with the C.K.C as a pure bred Épagneul Breton (Brittany [Spaniel]).

Both parents are certified 'exempt' of Hip Dysplasia by radiograph exam submitted to the O.F.A.

## Warranty

All puppies are sold with a limited warranty of 24 months against congenital and hereditary diseases, upon presentation of an exam done by a qualified veterinarian. As well against hip dysplasia, with a radiograph exam done between the ages of 24 to 30 months submitted to the O.F. A (Orthopedic Foundation for Animals Inc.); at the buyers costs.

If the delivered puppy does not pass any of the exams or meet the requirements mentioned above, the buyer will be provided a refund or given the choice of a puppy from another litter; at the discretion of the breeder. The breeder reserves the right to have any warranty claims checked by a qualified veterinarian of his choice, in the interest of having a second opinion, at his cost.
